- In high season (spring summer): water, electricity, WIFI, and heated swimming pool are included in the price.
- In winter (fall winter): water and electricity consumptions, WIFI, and wood for the fireplace are included in the price.
- Inventory of fixtures to be signed at the beginning and at the end of the stay, as well as a non-responsibility agreement
- A certificate by the tenant's insurer providing for the holiday guarantee must be provided with this contract.

• Minimum stay: 7 days

• Maximum stay: 90 days

• Arrival time: 3 p.m. to 5 p.m.

• Departure time: 12 noon maximum.

Allow 1/2 hour for the arrival and departure inventory.

### 3 - CANCELLATION:

- Vacationers who cancel at least 60 days before the arrival date will obtain a 100% refund.
- Vacationers who cancel 60 to 30 days before the arrival date will obtain a 50% refund.
- If the cancellation is made after the dates indicated, holiday-makers will not receive any refund.
- No refund will be granted in the event of late arrival or early departure.
- In the event of cancellation of the rental by the owner: the latter will pay the tenant the full amount he has received.

#### 4 - PAYMENT:

It is possible to pay:

- (a) By PayPal on the site www.double-perspective.com without creating an account.
- (b) Bank Transfer

#### 5 - SECURITY DEPOSIT:

- (a) For travelers who have booked via <a href="www.double-perspective.com">www.double-perspective.com</a>: €2,000 (two thousand euros) payable by Paypal or bank transfer at the same time as the amount of the stay.
- Return of the deposit within 5 days of the end of the stay via Paypal or bank transfer (in full if no damage is noted or with deduction of repair costs).
- Any damage or deterioration will be notified on the exit inventory.
- The repair amounts will be debited directly from the deposit or will be declared to the tenant's insurer.
- (b) For travelers who have booked via <u>Booking</u>, <u>Airbnb or Abritel</u>: Deposit of a deposit check of €3,000 upon arrival, or photocopy of your bank card used for the reservation, with delivery of your identity card or passport at the start of the stay.
- The identity card or passport will be returned at the end of your stay or after reimbursement for the damage caused.
- Signature of a certificate committing you to pay for any damage caused during your stay and notified on the exit inventory.
- (c) In both cases, you must provide a certificate of Hollidays resort insurance with this contract.

# 7 - <u>TERMS</u>:

- This rental will take effect upon receipt by email to <a href="mailto:double.perspective@orange.fr">double.perspective@orange.fr</a>, or by any other means within 48 hours of booking, of this contract duly completed and signed and the documents requested.
  - The full amount of the stay paid via PayPal or by any other means.
- Beyond these 48 hours, this rental proposal will be canceled and I will dispose of the furnished accommodation at my convenience.

# 8 - GENERAL PROVISIONS :

• The owner will provide the accommodation in accordance with the description he has made of it and will keep it in working order.

- The inventory of fixtures and the inventory of furniture and various equipment will be made at the beginning and at the end of the stay by the owner or his representative, and the tenant.
- The non-liability agreement must be signed and attached to this contract as well as the certificate of the vacation insurance.
- On entering the premises, the owner must offer his rental in a perfect state of cleanliness.

#### 9 - USE:
